Função Sexual e Prática de Atividade Física em Mulheres Primíparas no Puerpério Remoto

O objetivo do estudo foi associar a presença de disfunção sexual (DS) e a prática de atividade física (AF) em mulheres primíparas no puerpério remoto. Trata-se de um estudo transversal realizado com 242 primíparas que durante o puerpério remoto, residentes em um dos municípios das regiões da Associação dos Municípios do Sul do Estado de Santa Catarina (AMESC) e da Associação dos Municípios da Região Carbonífera (AMREC). A coleta de dados foi realizada por meio de um questionário online contendo informações sociodemográficas, obstétricas e de hábitos de vida, sendo a prática de atividade física autorrelatada pelas participantes. Para avaliação da função sexual (FS) foi utilizada a versão brasileira do questionário *Female Sexual Function Index* (FSFI). Realizou-se estatística descritiva e inferencial, com nível de significância de 5%. Os resultados demonstram que puérperas que não praticam AF regularmente possuem 2,27 vezes mais chances de desenvolver DS (OR= 2,27; IC95% 1,21 – 4,25), 2,48 mais chances de ter uma disfunção orgásmica (OR= 2,48; IC95% 1,33 – 4,63) e 2,14 mais chances de terem insatisfação sexual (OR= 2,14; IC95% 1,15 – 3,98) quando comparado com puérperas que praticam AF. Dessa forma, conclui-se que mulheres primíparas no puerpério remoto que não praticam AF regularmente possuem maiores chances de desenvolver DS, dentre elas a anorgasmia e insatisfação sexual.

Introdução

A sexualidade, segundo a Organização Mundial da Saúde (WHO, 2015), é influenciada pela interação de fatores biológicos, psicológicos, socioeconômicos e culturais, que constituem a relação pessoal fundamental do ser humano. Com isso, a função sexual (FS) depende de integrações equilibradas entre esses fatores, pois qualquer alteração que desvie da normalidade desse ciclo pode, potencialmente, causar desordens na resposta sexual, resultando em uma disfunção sexual (DS) (Mollaoglu, Tuncay & Fertelli, 2013; Rogers et al., 2018).

A prevalência mundial indica que 41% das mulheres adultas manifestam alguma DS durante a vida (McCool-Myers et al., 2018). No Brasil, uma revisão sistemática apontou que entre 13,3% e 79,3% das mulheres apresentam alguma DS (Wolpe et al. 2017). Segundo revisão sistemática de Alidost et al (2021) realizado com mulheres em idade reprodutível, o transtorno de desejo apresentou prevalência de 50,7% (IC 95%: 39,03-62,37), seguido por transtorno de excitação com taxa de 48,21% (IC 95%: 34,74-61,68), lubrificação com 37,60% (IC 95%: 19,69-55,50), anorgasmia 40,16% (IC 95%: 29,49-50,83), satisfação 35,02% (IC 95%: 28,99-43,75) e dor com 39,08% (IC 95%: 22,76-55,41). Altas taxas de prevalência dessas disfunções acarretam em grande impacto na qualidade de vida e nos relacionamentos interpessoais dessas mulheres (Basson et al. 2001).

O puerpério interfere na FS feminina e é classificado em três períodos: imediato (1º ao 10º dia pós-parto), tardio (11º à 42º dia pós parto) e remoto (a partir do 43º dia pós parto), estendendo-se até o retorno das condições fisiológicas ao estado pré-gravídico (Brasil, 2001). As DS mais comuns no puerpério são o transtorno do desejo (12,5%), transtorno de excitação (8%), disfunção orgásmica (10,5%), dispareunia (28,5%) e vaginismo (16%) (Holanda et al. 2014). Durante o puerpério ocorrem diversas alterações físicas, emocionais e comportamentais, que podem afetar a qualidade da vida sexual das mulheres (Hadizadeh-Talasaz, Sadeghi & Khadivzadeh, 2019).

Uma situação a ser discutida é a prática de atividade física (AF) no período pós-parto e sua influência na FS. Tem-se estudado que a prática de AF pode ser um elemento importante na prevenção de DS nas mulheres, considerando que alguns dos seus mecanismos fisiológicos possuem forte ligação com a FS feminina, tanto em aspectos hormonais, como emocionais e físicos (Macdowall, 2010; Peluso & Andrade, 2005).

Devido à essas considerações, torna-se necessário preparar os profissionais de saúde para que ofereçam suporte à puérperas, por meio de orientações a respeito da sexualidade feminina, do puerpério, da prática de AF, entre outras informações relevantes para a prática clínica (Bekele et al. 2020). Além disso, o fisioterapeuta, enquanto membro da equipe multidisciplinar, é um dos responsáveis em investigar as disfunções pélvicas, visando a cura das queixas para resgatar e/ou devolver a autoestima da mulher (Batista, 2017). Diante dessas informações o objetivo geral do estudo é associar a presença de DS e a prática de AF em mulheres primíparas no puerpério remoto.

Metodologia

Caracterização do Estudo

Trata-se de um estudo observacional do tipo transversal e quantitativo, realizado com mulheres primíparas durante o puerpério remoto e residentes em um dos municípios de duas microrregiões do sul catarinense: a Associação dos Municípios do Sul do Estado de Santa Catarina (AMESC) e Associação dos Municípios da Região Carbonífera (AMREC).

Critérios de inclusão e exclusão

Foram incluídas no estudo puérperas primíparas com gestação única, alfabetizadas, com idade igual ou superior a 18 anos, que estivessem no puerpério remoto no período inferior ou igual à 12 meses e que fossem ativas sexualmente nas últimas quatro semanas.

Foram excluídas do estudo puérperas primíparas com história de gestação anterior resultante de aborto após a 12ª semana ou de cirurgia uroginecológica nos últimos 3 anos; que apresentaram sinais e sintomas sugestivos de infecção urinária (disúria, hematúria, poliúria) nas últimas quatro semanas. Puérperas cujo filho (a) tenha necessitado de

internação hospitalar nas últimas quatro semanas ou que estavam grávidas durante a avaliação.

Procedimento de coleta de dados:

A coleta de dados foi realizada no período de março de 2020 à outubro de 2020. Para a seleção e divulgação do estudo, foram desenvolvidos perfis oficiais nas plataformas de comunicação Instagram e Facebook. Com o objetivo de alcançar o maior número de mulheres, o estudo também foi divulgado em grupos do WhatsApp. Para a coleta de dados foi desenvolvido uma versão online dos instrumentos de pesquisa, a partir da plataforma Google Forms. Os instrumentos foram organizados em seções com perguntas que foram respondidas no formato discursivo, múltipla escolha e/ou em caixas de seleção. Inicialmente as participantes foram instruídas a responder a ficha de caracterização da amostra e, posteriormente, o *Female Sexual Function Index* (FSFI). Para cada seção, também foi disponibilizado uma introdução com orientações relacionadas ao preenchimento das questões.

Com o intuito de evitar que as participantes pulassem as etapas e não respondessem todas as perguntas, os pesquisadores sinalizavam cada pergunta como item obrigatório. Ao final da avaliação, as puérperas receberam um folder online (via whatsapp/e-mail) com orientações sobre técnicas para fortalecimento do assoalho pélvico e melhora da FS.

Instrumentos de pesquisa:

Ficha de caracterização da amostra

O perfil das participantes foi avaliado por meio de uma ficha de caracterização da amostra, sendo coletado as seguintes informações: Perfil sociodemográfico: idade, estado

civil (solteira, casada/em união estável, separada/divorciada, viúva) escolaridade (ensino fundamental, ensino médio e ensino superior) e renda familiar (1 salário mínimo, 2 a 3 salários mínimos, superior ou igual a 4 salários mínimos); Fatores obstétricos: via de parto no nascimento (vaginal, cesárea), tempo de puerpério e se estava amamentando (sim, não); Medidas antropométricas autorrelatadas como peso (em quilogramas) e altura (em centímetros). Quanto aos hábitos de vida, foi verificada a prática de AF no período pós-parto/atual (sim, não). Em caso afirmativo, perguntava-se também o tipo e a frequência da atividade.

Female Sexual Function Index (FSFI)

O *Female Sexual Function Index* (FSFI) é um instrumento proposto por Rosen et al (2000) para avaliação da FS feminina. Sua validação foi realizada por Meston (2003) e Wiegel, Meston e Rosen (2005). No Brasil, foi traduzido e validado por Thiel et al (2008) e por Pacagnella, Martinez e Vieira (2009). Sua estrutura é composta por seis domínios (desejo, excitação, lubrificação, orgasmo, satisfação e dor) e 19 questões, pontuadas crescentemente entre zero e cinco. As questões 15 e 16 são as únicas que fogem a esse padrão de resposta, sendo classificadas de forma invertida e pontuadas entre um e cinco (Thiel et al. 2008). Seu escore total varia de 2 a 36 pontos e é representado pela soma dos escores de cada domínio multiplicado por um fator que equilibra a influência de cada categoria (Desejo: 0,6; Excitação: 0,3; Lubrificação: 0,3; Orgasmo: 0,4; Satisfação: 0,4 e Dor 0,4) (Rosen et al. 2000).

Além da avaliação global, os domínios do FSFI também podem ser categorizados a partir dos pontos de corte descritos por Jamali, Rahmanian e Javadpour (2016). Segundo os autores, valores inferiores à 4,8 para desejo, 5,0 para excitação, 5,4 para lubrificação, 5,0 para orgasmo, 5,0 para satisfação e 5,5 para dor indicam uma DS nos respectivos domínios (Jamali, Rahmanian & Javadpour, 2016). Quanto ao escore total do FSFI, um

valor inferior a 26,55 pontos sinaliza que a mulher possui uma DS (Wiegel, Mestson & Rosen, 2005).

Aspectos éticos

Esta pesquisa foi fundamentada nos princípios éticos, com base na Resolução nº 466 (2012), do Conselho Nacional de Saúde (CNS). O estudo pertence também a um projeto guarda-chuva denominado “Estudo DAP SUL: Avaliação dos Desconfortos do Assoalho Pélvico na Região Sul do Brasil”, aprovado sob parecer (CEP/UFSC: 3.357.956) e CAAE: 13189919.0.0000.0121.

Análise estatística

As análises foram realizadas no software estatístico SPSS – *Statistical Package for Social Sciences* (versão 22.0 IBM®). As variáveis foram analisadas descritivamente por meio de frequência simples e porcentagens (variáveis categóricas) e medidas de posição e dispersão (variáveis numéricas). A associação entre as variáveis categóricas foi realizada por meio do Qui-quadrado de Pearson ou pelo teste exato de Fisher, conforme a necessidade. As variáveis com $p < 0,2$, na análise bivariada foram inseridas no modelo de regressão logística binária para determinar os fatores associados a presença de DS (baseado no escore total e domínios do FSFI). Para todas as análises estatísticas foi adotado o valor de $p < 0,05$ para indicar diferença estatisticamente significativa entre os grupos.

Resultados

Inicialmente, 359 mulheres acessaram o questionário online, porém 117 foram excluídas do estudo por não apresentarem os critérios de elegibilidade. Assim, a amostra foi composta por 242 mulheres com média de idade de 27,28 ($\pm 4,8$) anos. Quanto aos dados sociodemográficos, 53,7% (n=130) eram casadas, 55,0% (n= 133) possuíam ensino

superior completo e 35,5% (n=86) tinham renda familiar maior ou igual a 4 salários mínimos (4.180,00), conforme demonstrado na Figura 1.

A associação entre a presença de DS e fatores obstétricos, antropométricos, amamentação e prática de atividade física (AF) estão apresentados na Tabela 1. Da amostra total 55,4% (n=134) das mulheres apresentaram DS no puerpério remoto. Além disso, pode-se observar que houve associação entre a prática de AF e a DS, de modo que as puérperas que não praticam AF tendem a ter DS (n=113; 60,1%).

Na Tabela 2, a análise de regressão ajustada aponta que as puérperas que não praticam AF regular tem 2,27 vezes mais chances de desenvolver DS quando comparado com aquelas que praticam AF (OR= 2,27; IC95% 1,21 – 4,25).

Na Tabela 3, pode-se observar a chance de ocorrência de DS (baseado nos domínios do FSFI), conforme a prática de AF no puerpério. As DS mais comuns na amostra total foram desejo hipoativo (88,0%) e falta de excitação (74,8%). As mulheres que não praticam AF regular possuem 2,48 vezes mais chances de apresentar disfunção orgástica do que aquelas que praticam AF regularmente (OR= 2,48; IC95% 1,33 – 4,63). Além disso, a chance de insatisfação sexual é 2,14 vezes maior entre as puérperas que não praticam AF regularmente (OR= 2,14; IC95% 1,15 – 3,98).

Discussão

Este estudo teve como objetivo associar a presença de DS e a prática de AF em mulheres primíparas no puerpério remoto. Os resultados encontrados indicam que puérperas que não praticam AF regularmente possuem maiores chances de desenvolver DS, disfunção orgásmica e insatisfação sexual quando comparado com mulheres que praticam AF.

Sabe-se que a AF é uma intervenção não farmacológica segura e amplamente reconhecida por seus benefícios na saúde física e mental (Stanton, Handy & Meston,

2018; Aibar-Almazán et al., 2019). Segundo American College of Obstetricians and Gynecologists (2015), a prática de AF no pós-parto auxilia na diminuição de sintomas depressivos, contribui na manutenção ou na perda de peso pós gestação e melhora a aptidão física durante o puerpério. Além disso, é considerada um elemento importante na prevenção de DS em mulheres, visto que os seus mecanismos fisiológicos possuem ligação com sistemas corporais que podem afetar a excitação sexual (Calabrò et al. 2019).

No presente estudo observamos que as mulheres que não praticavam AF regularmente apresentaram maiores chances de desenvolver DS, o que vai ao encontro de Hamer, Coombs e Stamatakis (2014), que observaram que um estilo de vida sedentário está associado a resultados negativos para a saúde física e emocional, incluindo a redução da atividade sexual e conseqüentemente a maiores problemas sexuais. Ao observar os diferentes domínios da FS, Maseroli et al., (2021) observaram que, mulheres que realizavam AF regularmente obtiveram uma pontuação maior nos domínios de desejo, excitação e lubrificação, bem como demonstraram menor angústia relacionada a sua vida sexual. Essa relação pode ocorrer, pois, a inatividade física pode auxiliar no surgimento de patologias metabólicas que vão contribuir para o aumento de citocinas pró-inflamatórias e acarretar uma inflamação, interferindo no desejo e na excitação sexual através de vias diretas (neurais) e indiretas (endócrinas, vasculares, sociais e comportamentais), interferindo nos demais domínios da FS (Rodrigues et al., 2015; Maiorino et al., 2018).

Além disso, identificamos que a ausência da prática de AF é um fator de risco para a anorgasmia, o que se confirma no estudo de Nazarpour et al. (2016) em que a frequência de AF teve correlação positiva com melhores escores nos domínios de lubrificação ($r = 0,18$, $P = 0,014$) e orgasmo ($r = 0,146$, $P = 0,045$) em mulheres pós-menopausa. Sendo assim, quando a frequência de AF se torna regular, realizada ao menos uma vez na

semana, podemos observar efeitos positivos nos domínios de lubrificação e orgasmo (NAZAPOUR et al,2016). Assim como no estudo de Christensen et al (2011), realizado com mulheres em idade fértil, em que foi observado que um estilo de vida pouco saudável, com má alimentação e ausência da prática de AF estava associado ao desenvolvimento de anorgasmia (OR = 2,85, IC 5% 1,18–6,85).

Em uma revisão sistemática foi observado que mulheres que mudaram o estilo de vida e introduziram a AF no seu cotidiano, relataram maior frequência de relações sexuais e maior lubrificação vaginal, além de apresentarem maior pontuação nos domínios de satisfação e orgasmo (Wekker et al. 2018; Mutsaerts et al. 2016). Esses resultados podem ser justificados pelo fato de a AF afetar a excitação, atuando em hormônios como o cortisol, estrogênio, prolactina, ocitocina e testosterona, hormônios esses que têm sido associados com a lubrificação e excitação sexual (Meston & Stanton, 2017; Smith et al. 2019; Rojas, Hollmann & Struder, 2012; Vingren et al, 2012).

Em relação a insatisfação sexual, observa-se que as mulheres que não praticavam AF demonstraram maior insatisfação sexual quando comparado com mulheres que realizavam AF regularmente. Isso pode ser influenciado pela associação com a imagem corporal distorcida após o parto, levando a insatisfação sexual e a respostas aversivas ao sexo (Alligood-Percoco, Kjerulff & Repke, 2016). O'Malley et al (2018) encontraram associação entre a percepção da imagem corporal com DS em mulheres no pós-parto, sendo que as puérperas que relataram pior imagem corporal entre 6 e 12 meses pós-parto eram mais propensas a ter déficit de lubrificação, redução da satisfação e interesse sexual, dados associados com excesso de peso, obesidade e amamentação.

A ausência de AF está intimamente relacionada a obesidade e ao surgimento de doenças cardiometabólicas, contribuindo na redução da atividade sexual (Miranda et al. 2016; Iannotti & Wang, 2013). Quando ocorre redução do fluxo sanguíneo pélvico que

pode ser secundário a uma patologia cardiovascular, ocasiona fibrose da parede vaginal e do músculo liso do clítoris, prejudicando dessa forma a lubrificação vaginal e conseqüentemente diminuição do desejo sexual (Costa & Brody, 2012). Além disso, a prática de AF está associada a melhora do humor e redução do estresse, uma vez que a transmissão sináptica de monoaminas e liberação de opioides endógenos, possuem efeito calmante e melhoram o humor após a prática, influenciando também indiretamente na satisfação sexual (Dinas, Koutedakis & Flouris, 2011; Mead et al. 2008).

Diante disso, a prática de AF está intimamente relacionada com a DS feminina visto que seu impacto na saúde física de forma global possui influência direta no bem-estar físico e emocional de puérperas (Smith et al. 2019). Contudo, vale ressaltar que apesar da importância de entender melhor a relação da DS com a prática de AF em mulheres no puerpério remoto ainda são escassos estudos que abordem esse tema na literatura.

Limitações:

Uma das limitações do estudo foi a avaliação das mulheres durante a pandemia de SARSCOV-2, uma vez que a prática de AF durante esse período poderia estar comprometida devido às medidas de isolamento, além do impacto psicossocial causado pela pandemia o que pode ter tido influência na FS e seus domínios.

Conclusão:

Conclui-se que mulheres primíparas no puerpério remoto que não realizam a prática de AF regularmente possuem maiores chances de desenvolver DS, anorgasmia e insatisfação sexual quando comparado com mulheres que praticam AF. Dessa forma, é importante o preparo de profissionais da saúde a orientação e encorajamento das mulheres sobre a sexualidade feminina, puerpério e os benefícios da prática de AF. Além disso, a escassez de conhecimento sobre o tema pode refletir diretamente na saúde sexual. Além

disso, a discussão desses itens durante a consulta pré-natal pode beneficiar a compreensão e conseqüentemente a qualidade de vida para a mulher e seus relacionamentos pessoais.

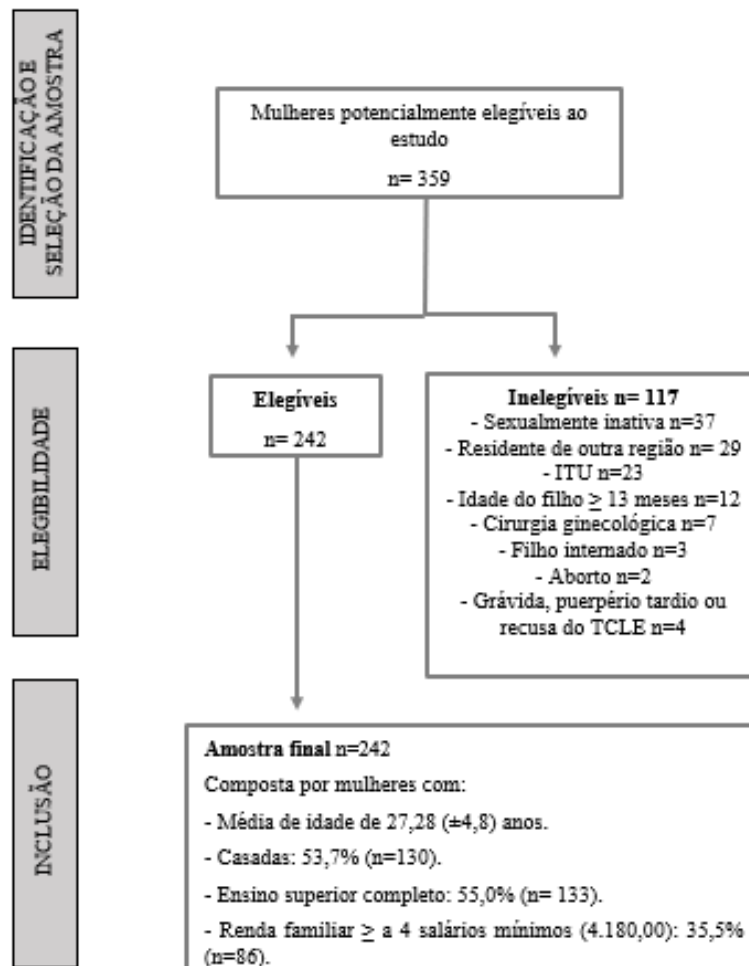
